Statutory fees payable under applicable legislation, including registration and search fees are set by the Province of Ontario.

As part of the established annual fee adjustment process, fees for certain land registration services will be adjusted effective November 2, 2026.

As part of recent updates to the land registration services agreement, the annual CPI adjustment applicable to certain fees has been revised for the remainder of the license term. The new fees set out in Schedule I below reflect a 1.4 to 1.68 per cent increase pursuant to the applicable Consumer Price Index (CPI) adjustment.

The fees set out in Schedules II and III will not be increasing (See attached Fee Schedules I, II and III).

Please note that Harmonized Sales Tax (HST) is only applicable on the Electronic Land Registration Services Act, 2010 (ELRSA) fee and has been listed in the fee schedules below.

More information on this annual adjustment, which commenced on November 2, 2015, is provided in [Bulletin 2010-02](#).
